
1. **Call to Order:** President Erica Reif called the meeting to order at 12:04 p.m.
2. **Minutes:** Meeting minutes from the June 12, 2024 meeting were passed out prior to the meeting and those present looked over the minutes momentarily. Erica Kish made a motion to accept the minutes as presented, Kathy McQueen seconded, motion carried.
3. **Treasurer's Report:** No official report was given. It was noted that incoming bills included: Microsoft and Minted (signs and t-shirts).
4. **Unfinished Business:**
 - a. **Santa's House:** A roof donation sign was purchased for \$20 and will be added above the tire next to the door. New signs for the Santa's House and Information/Ticket Booth were purchased for \$275 and will be easily removable.
 - b. **Chamber T-Shirts:** T-shirts have arrived from Minted. 75 shirts were ordered for \$575 and range from SM to 3XL.
 - c. **Farmer's Summerfest Volunteers:** Volunteers are needed to run the Information/Ticket Booth for Friday and Saturday.
 - d. **Farmer's Market:** All is continuing to run smoothly. October 18th is the only open date for a food truck.
 - e. **Social Media Sharing:** Those present were reminded to share Chamber posts and events to their personal Facebook pages. Improvement on this has already proven successful.
 - f. **Quarter Mania:** Event Center booked for March 15, 2025. A committee for the event will be formed after the Farmer's Summerfest.
5. **New Business:**
 - a. **Casino Night:** Event Center booked for November 9th. A committee will be formed shortly to work out exact details of the event. An overall concept of the event was presented by Erica Kish. Kish noted the following: attendance goal of

175, games from 7-10pm, \$75 per ticket (est.), two drinks included with ticket, sponsorship letters will be sent out, Casino Party Experts (tentative business to go with) will provide dealers and all accessories for \$7,600 (est.), Marcine Moore will cater event. Anne Eichler motions to have the event, seconded by Amanda Scott. Motion passed.

6: **Farmer's Summerfest Report:** Linda Walsh gave an update on the Farmer's Summerfest. Anything Goes Games are canceled. Those present were asked to share the events on Facebook. The need of volunteers for the Ticket/Information Booth was also reiterated.
